

**AMENDMENT #1 TO THE
INMATE HEALTH SERVICES CORRECTIONAL HEALTHCARE AGREEMENT
CMTS #12799**

THIS AMENDMENT is made and entered into effective the 22nd day of July, 2014 by and between the City of Henderson, Nevada, a municipal corporation and political subdivision of the State of Nevada, hereinafter referred to as "CITY," and Corizon Health, Inc., (formerly PHS Correctional Healthcare), hereinafter referred to as "CONSULTANT," for inmate health services, hereinafter collectively referred to as "Services."

RECITALS

WHEREAS, the CITY is charged by law with the responsibility for obtaining and providing reasonably necessary medical care for inmates of the City of Henderson Detention Center; and

WHEREAS, the CITY entered into an agreement with CONSULTANT for such services on June 21, 2011; and

WHEREAS, the CITY would like to exercise the first option year; and

NOW, THEREFORE, in consideration of the promises and the terms contained herein, the parties agree as follows:

The Agreement is hereby amended as follows:

ARTICLE VIII. TERM AND TERMINATION OF AGREEMENT

The term of the Amendment shall be July 1, 2014 through June 30, 2015.

ARTICLE IX. COMPENSATION

This section is amended to add the base compensation of \$1,696,349.33, for option year one.




